**Sub : Limited Departmental Competitive Examination for the post of LDC**

Madam,

It is to inform you that competent authority has decided to hold limited Departmental Competitive examination for the post of LDC . All the serving MTS of FRI/ICFRE, who fulfill the requirements as per the norms specified by Govt. of India /ICFRE in the recruitment rules for the above post, may apply for the examination scheduled to be held on 30.10.2017 .

The syllabus for the competitive examination will comprise of 3 subjects as under :-

S. No.		Subject	Max. Marks	Time Allotted
1	Paper-I	Short Essay ( *Hindi or English) – Descriptive Type	100	1 hr 30 min.
2.	Paper- II	Language (*Hindi or English) **Objective Type General Knowledge (*Hindi or English) **Objective Type	50 50	2 hrs.

\*Candidate will have an option to answer the question papers either in Hindi or in English, for which, at the time of applying for the test, he/she will indicate their option to answer the paper in Hindi or in English. The option once exercised will be final.

\*\* In paper 2 , there will be negative marking of 0.25 marks in case of each wrong answer.

DPC will assess the Work & Conduct Reports of those who obtain the minimum 40% of the aggregate qualifying marks in the written test papers and the merit list will be approved by the DPC.

The Venue and Timing of the above papers will be informed in due course.

You are therefore requested to identify the number of vacancies in reserved /Un-reserved categories and inform all the eligible candidates to apply for the identified posts. Appointment as LDC, on the basis of result of this examination shall be subject to the condition that the selected candidates will have to pass the typing test within 1 year from the date of appointment failing which no annual increment will be allowed. The candidate who do not pass the typing test within the period of probation shall liable to be reverted to their post held by them before their appointment to post of LDC.

The applications of the eligible candidates for appointment under limited Departmental competitive examination for the post of LDC along with their work and conduct report must reach this office on or before 16.10.2017.
